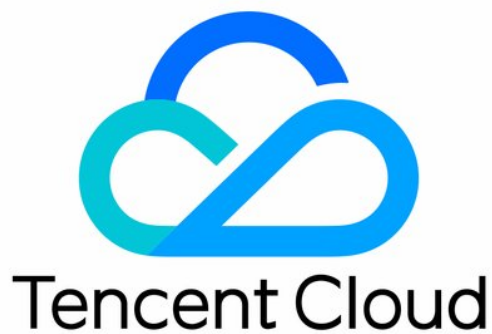

# Purchase Guide

## Billing Overview

Note :

Tencent Cloud Elastic Microservice (TEM) will be commercialized from July 18, 2022 at 10:00:00 (UTC+8). You can check your bills in [Billing Center](#). For the billing mode and billing cycles, please see below.

## Billing Mode

TEM is a **pay-as-you-go** service.

You are billed according to the actual resource usage. No upfront payment is required. The costs generated by resource consumption will be automatically deducted from your Tencent Cloud account according to the settlement cycle.

## Billable Items and Periods

The service fees of TEM include the **environment fee** and **application fee**. The application fee contains two parts, **CPU** and **MEM**.

Billing periods:

- Environment fee: Starts billing when the environment is created successfully, and ends when the environment is terminated.
- Application fee: Starts billing when the instance resource is assigned and it's ready to load the application image, and ends when the instance stops running.

## Billing Cycle

TEM service is billed per minute. The usage period less than one minute is counted as one minute.

## Settlement Cycle

TEM service is settled on an hourly basis. The spend of the previous cycle is deducted from your account every hour.

## Related Services

Other products used by TEM, such as [CFS](#), [COS](#), and [CLS](#), will be billed according to their respective billing rules.

## Billing Example

See below for the billing example.

- An environment is created on August 1, 2022 at 10:00:10, and then terminated on August 1, 2022 at 10:29:40.
- An application is deployed in the environment on August 1, 2022 at 10:15:20, with five 1C2GiB instances created. All the instances are stopped on August 1, 2022 at 10:24:59.
- There are no other TEM resources in used.

In the case, the billing for the TEM service is calculated as below:

Category	Spec	Duration (one minute minimum charge)	Amount
Environment fee	One	30 mins (Aug/1/2022 10:29:40 - Aug/1/2022 10:00:10 = 29 mins 30 secs)	0.0074628 USD (0.00024876 * 1 * 30)
Application fee	Five 1C2GiB instances	10 mins (Aug/1/2022 10:24:59 - Aug/1/2022 10:15:20 = 9 mins 39 secs)	0.027622 USD (5 * (1 * 0.00031344 + 2 * 0.0001195) * 10)

The total cost is 0.0350848 (0.0074628+0.027622) USD.

# Overdue Policies

## Service Suspension

When your Tencent Cloud account goes overdue, the following policies are applied to TEM resources under your account:

- $\leq 24$  hours: The billing and running of all existing environments and instances remain normal.
- $> 24$  hours and  $\leq 7 \times 24$  hours: The billing and running of all existing environments remain normal. **All instances stop running.** You cannot create or modify environments and applications.
- $> 7 \times 24$  hours: All environments and applications under the account are terminated permanently. The billing stops.

## Service Recovery

When the overdue payment is made, TEM service is recovered.

- Environments and running instances are recovered automatically without any change.
- Applications stopped need to be manually enabled again.
- Terminated resources cannot be restored.
