We process this information as it is necessary for us to perform our contract with you to provide the Feature.

Log Data :device log (if you enable collection of this data)	We only process this data according to your configuration to facilitate debugging or troubleshooting by you. Please note that this data is stored and backed up with our Elasticsearch Service feature. Additionally, you may also use our Cloud Log Dump feature to store and analyze the data.
Configuration Data : settings of products (product name, product ID), devices (device name, device key/certificate) and rules (SQL statement)	We only process this data to facilitate product and/or device identification and management by you. Please note that this data is stored and backed up with our TencentDB for MySQL feature.
Monitoring Data : statistics of online devices, device messages, device shadows, rule engine and firmware	We only process this data to provide you with statistics of your use of the Feature. Please note that this data is stored with and managed by our Cloud Monitor feature. This data is backed up with our TencentDB for MySQL feature.
Resource Data :resources related to platforms and devices uploaded by you (if you include personal data in such resources)	We only process this data to enable you to provide such data to your end users. Please note that this data is stored and backed up with our Cloud Object Storage feature.

Published Device Data : type of device, state of device, rules and commands for controlling the device by SQL statement	We only process this data for device verification and message forwarding as instructed by you. Please note that we have no access to this data. This data is transferred to other service(s) as instructed by you.
Subscriber Device Data :device command message	We only process this data to facilitate control of device(s) by your end users. Please note that we have no access to this data. This data is transferred to other service(s) as instructed by you.

Configuration Data	Stored until you request for account deletion, upon which such data will be deleted within 30 days. Where you do not request for deletion, such data will be deleted within 30 days of the earlier of the date that overdue amounts become payable on your account, termination of your use of this Feature, or shutdown of this Feature.
Resource Data	Stored until you request for account deletion, upon which such data will be deleted within 30 days. Where you do not request for deletion, such data will be deleted within 30 days of the earlier of the date that overdue amounts become payable on your account, termination of your use of this Feature, expiration of your Feature subscription, or shutdown of this Feature.



Personal Information	Retention Policy
Monitoring Data	Stored for 7 days.
Published Device Data	Not stored.
Subscriber Device Data	Not stored.
