Please note that Instance ID is also shared with our TencentDB for Redis, Cloud Virtual Machine and Tencent Cloud Lighthouse features for this purpose, including to provide you with records of the use of the Feature. APPID, UIN, sub account UIN, client IP, instance ID and command ID will also be integrated with our Tag feature for cloud resource management.</p>
