<b>Images uploaded by you (such as of you or your end users’ cards, certificates and documents), and returned results (such as information extracted from the uploaded images)</b>	We only process this data for the purposes of providing the Feature to you. Please note that this data is integrated with the Cloud Object Storage feature for this purpose. The Feature will not further process the images once the OCR services (in accordance with your request) is complete.
