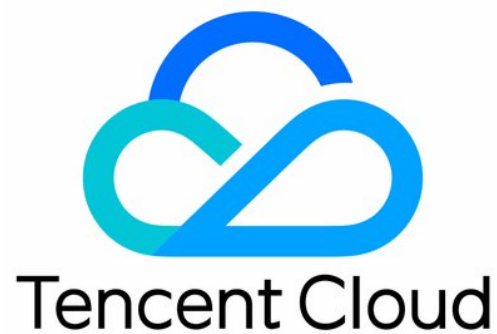

We process this information as it is necessary for us to perform our contract with you to provide the Feature.

Please note that this data is stored and backed up in our TencentDB for MySQL feature. Please note that we have no access to your CMK before encryption.

5. DATA RETENTION

We will store personal data processed in connection with the Feature as follows:

Encryption Data	Stored until you request for deletion, upon which such data will be deleted within 5

	working days, unless otherwise required by applicable data protection laws. Where you do not request for deletion, such data will be deleted after 1 month of termination of your use of this Feature, unless otherwise required by applicable data protection laws.
Encryption Properties Data	Stored until you request for deletion, upon which such data will be deleted within 5 working days, unless otherwise required by applicable data protection laws. Where you do not request for deletion, such data will be deleted after 1 month of termination of your use of this Feature, unless otherwise required by applicable data protection laws.

You can request deletion of such personal data in accordance with the DPSA.

6. SPECIAL CONDITIONS
