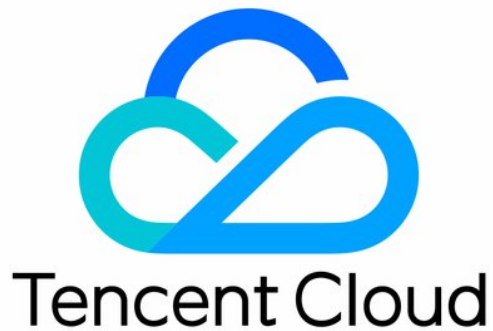

#### 2. PROCESSING

We will process the following data in connection with the Feature:

Personal Information	Use
<b>Configuration Data</b> (security group (name, state, id), input (name, type, status, ID, URL) and channel (name, status, input count, and ID))	We only process this data for the purposes of providing the Feature to you and your end users.
<b>Live Streaming Data</b> (video and audio data)	

#### 3.SERVICE REGION

#### 5.DATA RETENTION

We will store personal data processed in connection with the Feature as follows:

- **Configuration Data:** until you manually delete such data.
- **Live Streaming Data:** temporarily cached on servers during the livestream.
