# 2. PROCESSING

We will process the following data in connection with the Feature:

Customer License Data (provided by you): data to enable you to unlock access to the SDK, namely package name, bundle ID, APPID, license URL, license key	We use this information for the purposes of providing the Feature to you, including troubleshooting.  Please note that this data is stored in our Cloud Log Service (CLS) and TencentDB for MySQL (MySQL) features, and backed up in our MySQL feature.

Please note that we do not collect, process, store or otherwise have access to the end user's facial data or short videos/content generated using this Feature ("**UGC Content**"). UGC Content is processed by you and/or your product, service or platform (as applicable) that integrates the Feature.

# 5. DATA RETENTION

We will store personal data processed in connection with the Feature as follows:

Personal Information	Retention Policy
Customer License Data	We retain such data until you log off your Tencent Cloud account. Otherwise, if you request deletion of this data, we will delete such data immediately.

You can request deletion of such personal data in accordance with the DPSA.

## 6. SPECIAL CONDITIONS
