## Billing Overview

CHDFS is billed at pay-as-you-go rates according to the actual storage usage and bandwidth. The billing cycle of each item may be different.

## Billable Items

CHDFS billable items are described as follows:

Billable Item	Description	Calculation Formula
Storage usage	Calculated based on the STANDARD storage usage	STANDARD storage usage fees = Unit price of STANDARD storage x Monthly accu
Bandwidth	Calculated based on the bandwidth	Bandwidth fees = Bandwidth unit price x Monthly bandwidth
