

Purchase Guide Billing Overview

This document introduces the billing mode and billable items of Tencent Cloud EventBridge.

Billing Mode

EventBridge is provided in a pay-as-you-go manner.

Туре	Pay-as-you-go	
Billing mode	Bill by the number of events published to event buses and settled on an hourly basis	
Unit price	USD/million events	
Use cases	Low or fluctuating message volumes	

Pricing Details

EventBridge is billed according to the event bus type:

Tencent Cloud service event bus: The Tencent Cloud service event bus of the Gangzhou region is not billed.

Custom event bus: Event buses created by users in each region are billed based on the number of events delivered to the event buses.

Billing Example

If you receive 3 million events in a month, with 2 million sent to the default event buses for Tencent Cloud services, and 1 million sent to your custom event buses, you will be billed as follows:

Total events: 3 million (64 KB or less per event)

Tencent Cloud service events: 2 million (free of charge)

Custom events: 1 million

Cost for the current month = 1 million * 0.64 USD / 1 million = 0.64 USD



Other Fees

You may also need to pay for the usage of other Tencent Cloud services related with EventBridge, such as COS and CKafka. Check the pricing details of the other services in relevant documentations.

EventBridge is billed according to the event bus type:

Tencent Cloud service event bus: The Tencent Cloud service event bus of the Guangzhou region is not billed. **Custom event bus**: Event buses created by users in each region are billed based on the number of events delivered

to the event buses.

Delivery event fee details

You are billed in tiered mode based on the number of events delivered to your **custom event buses**, such as custom applications, message queues and databases. Details are as follows:

Tier 1	N ≤ 1,000	0.64	0.832

Tier 4	10,000 < N ≤ 50,000	0.416	0.5408
Tier 5	N > 50,000	0.384	0.4992

Note:

Every 64 KB of data is counted as one event. When the data is less than 64 KB, it is rounded up. For example, 256 KB is counted as four events, and 220 KB is also counted as four events.



Overdue Payments and Service Suspension

Note:

If you are a customer of a Tencent Cloud partner, the rules regarding resources when there are overdue payments are subject to the agreement between you and the partner.

Fee Freeze

Before **you create a custom event bus**, an amount of \$0.615 on your account will be frozen in advance according to the usage specification of 1,000 million events (the event bus cannot be created if your account balance is less than the amount to be frozen). After you proactively delete the event bus resource, the frozen amount will be unfrozen. The frozen amount is not actually consumed and cannot be used in the frozen state. After being unfrozen, the frozen amount can be used again.

Billing Cycle

EventBridge adopts the pay-as-you-go (postpaid billing) mode. It calculates the fee for usage in the previous hour at the start of each hour, and calculates the fee for the whole day and deducts the fee from your voucher or account balance at midnight. At the same time, a bill is generated for your reference.

Rules for Service Suspension

If your account has overdue payments, your EventBridge service will be suspended. After EventBridge service is suspended, all custom event bus resources are subject to the following restriction:

Events cannot be delivered to event buses through APIs or connectors.

Note:

Overdue payments do not affect the normal use of Tencent Cloud service event buses. Your alarm events and audit events can still be delivered and pushed properly.

Service Resumption

When all the overdue payments under your account are paid, the service will be resumed automatically: Custom event buses can receive delivered events properly.
