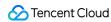

Application management information : application name, type, release time and status; transmission and data permissions, field management; device name, type and location.	We only process this data for the purposes of providing the Feature to you.	
Equipment management information : device identifier, name, type, shadow and associated application; operations log.		
Data service information: data indicators, project standard object model.		
Monitor alarm information : alarm list, alarm allocation rules, and message convergence rules.		
Linkage configuration : linkage management information, event management information, and action management information.		
Project information: basic information and configuration information.

5.DATA RETENTION

We will store personal data processed in connection with the Feature as follows:

You can request deletion of such personal data in accordance with the DPSA.
