## 5. DATA RETENTION

We will store personal data processed in connection with the Feature as follows:

Personal Information	Retention Policy
Original Log Data	We retain such data until you manually delete such data. Otherwise, such data is stored for 30 days.
Indicator Data	We retain such data until you manually delete such data. Otherwise, such data is stored for 15 days.
Project Data	We retain such data until you manually delete such data. Otherwise, we retain such data for 1 year (other than project ratings and PV/UV data which are stored for 90 days).

You can request deletion of such personal data in accordance with the DPSA.

## 6. SPECIAL CONDITIONS

You must ensure that this Feature is only used by end users who are of at least the minimum age at which an individual can consent to the processing of their personal data. This may be different depending on the jurisdiction in which an end user is located.
