Please note that this data is temporarily stored and backed up in our Cloud Log Service (CLS) feature.	We process this information as it is necessary for us to perform our contract with you to provide the Feature.

<b>Configuration Data</b> , including purchased APP ID, APP name.	We use this information for the purposes of providing the Feature to you, including for debugging and log-in verification purposes. Please note that this data is stored and backed up in our TencentDB for MySQL (MySQL) features.	We process this information as it is necessary for us to perform our contract with you to provide the Feature.

## 1. BACKGROUND

In the event of any conflict between the DPSA and this Module, this Module shall apply to the extent of the inconsistency.

## 2. PROCESSING

We will process the following data in connection with the Feature:

Personal Information	Use
<b>Log Data</b> , including: 1. Backend logs: User ID, users’ IP, OS type associated with any users participating in the Feature’s live streaming functionality, room numbers, users’ SDK versions; and 2. SDK logs: user ID.	We only process this data for the purposes of providing the Feature to you. Please note that this data is temporarily stored and backed up in our Cloud Log Service (CLS) feature.
<b>Quality Monitoring Data</b> , including: APP ID of users, video and audio functionality information (whether enabled or disabled, as selected by users), information relating to users entering a room, leaving a room, room ID, the use of the mute function, CPU usage , memory usage, network latency, packet loss, resolution, bitrate, frame rate, and volume.	We only process this data for the purposes of providing the Feature to you and for verification, debugging and service optimization purposes. Please note that this data is stored and backed up in our TencentDB for MySQL (MySQL) features.
<b>Business Data</b> , including the audio and video files recorded by you and our users during classes.	We only process this data for the purposes of providing the Feature to you, to enable the cloud recording (should you wish to record the classroom session) and storage functions that the Service offers. Please note that this data is stored and backed up in our Cloud Object Storage (COS) feature

### 5. DATA RETENTION

We will store personal data processed in connection with the Feature as follows:

Personal Information	Retention Policy
Log Data Quality Monitoring Data	We retain such data for 180 days, after which it will be automatically deleted.
Business Data	We retain such data until you tell us to delete it using your cloud account functionality, or until your use of the Feature ceases. We will delete your data immediately after your valid request, or within seven days after your use of the Feature ceases.

You can request deletion of such personal data in accordance with the DPSA.

### 6. SPECIAL CONDITIONS

You must ensure that this Feature is only used by end users who are of at least the minimum age at which an individual can consent to the processing of their personal data. This may be different depending on the jurisdiction in which an end user is located.
