1. BACKGROUND

2. PROCESSING

We will process the following data in connection with the Feature:

Please note that this data is stored in our TencentDB for MySQL feature. |
| Business Data: Your content (data, files and software) that you choose to upload to or store on the Feature (if your content contains personal data) | We only process this data for the purposes of providing the Feature to you. Please note that you may opt to store such data on our Cloud Block Storage and/or Cloud Object Storage features. Please note that we have no access to the personal data, if any, stored in the database or control over the data (unless you expressly authorize us to do so, such as for troubleshooting). |

3. SERVICE REGION

5. DATA RETENTION

We will store personal data processed in connection with the Feature as follows:

| Personal Information | Retention Policy |

| Configuration Data | We retain such data until you delete the cloud server instance or 7 days after the cloud server instance expires (whichever is earlier). |
| Business Data | We retain such data in accordance with your instructions (including if you opt to store such data on our Cloud Block Storage and/or Cloud Object Storage features). |

You can request deletion of such personal data in accordance with the DPSA.

6. SPECIAL CONDITIONS

You must ensure that this Feature is only used by end users who are of at least the minimum age at which an individual can consent to the processing of their personal data. This may be different depending on the jurisdiction in which an end user is located.
