Identity verification directly affects the ownership of accounts and resources in Tencent Cloud. If an enterprise account uses individual identity verification, then future changes in personnel or other account issues may have an impact on the enterprise's business operations and may lead to financial losses. Before performing identity verification, make sure to confirm whether the Tencent Cloud resources you purchase are used for individual or enterprise operations.

Note

- For individual identity verification, the same identity information (ID number) can be used to verify up to three Tencent Cloud accounts.
- For enterprise identity verification, the same enterprise identity information (enterprise name/business license) can be used to verify up to ten Tencent Cloud accounts. If the number of verified accounts does not meet business requirements, please contact your account manager for assistance.
- To apply for ICP, ensure that the name used in identity verification matches the name of the filing entity; otherwise, the ICP application will fail.
- After completing identity verification, you must wait 30 days to submit a request for identity information change; there is no time restriction for changing an individual entity to a corporate entity.
- Individual identity verification can be changed to another individual or enterprise verification. For specific steps, please see [Change Individual Authentication Information](#).
- Individual users from Hong Kong (China), Macao (China), and Taiwan (China) can complete identity verification by authorizing reserved identity information via WeChat scan code. The WeChat account must use the Hong Kong and Macao Residents' Travel Permit to Mainland China or the Taiwan Residents' Travel Permit to Mainland China for real-name authentication and must be linked to a Mainland bank card.
- Individual real-name authentication supports Chinese mainland residents using ID cards, Hong Kong and Macao users using the Mainland travel permit, and Taiwan (China) users using the Travel Permit to Mainland China. For other types of international ID, please verify your identity at the [International Site](#).
- Individual identity verification is available for users aged 18 and above.



If your Tencent Cloud account and resources belong to your enterprise, or if you want to participate in enterprise-related activities on the Tencent Cloud official website, you need to complete enterprise real-name authentication. The enterprise authentication supports the following methods:


 **Attention:**

Non-industrial and commercial enterprises cannot use the Corporate Legal Person WeChat QR Code Authentication method. They can authenticate via Corporate Legal Person Face Recognition.

Authentication Method	Authentication duration	Description
WeChat Official Account Authentication	Immediate completion	For enterprises with registered WeChat official accounts that have undergone WeChat real-name authentication, this method allows immediate authentication.
Corporate Legal Person WeChat QR Code Authentication	Immediate completion	Using the corporate legal person's personal WeChat for QR code authentication. Upon WeChat scan authorization by the legal person, the authentication is completed.
Corporate Legal Person Face Recognition Authentication	Immediate completion	Using the corporate legal person's personal WeChat for Face Recognition. After successful Face Recognition, the authentication is completed.

Tencent Cloud Recharge Authentication	1 business day	By recharging a specific small amount randomly generated by the system (less than 1 yuan) into the corporate bank account (the amount will be credited to the balance), the authentication will be completed once Tencent Cloud receives the payment.
Corporate Public Remittance Authentication	1-5 business days	Enter the corporate bank account information. After Tencent Cloud successfully makes the payment, fill in the payment amount to complete the authentication.

If inaccurate, please correct it manually (i.e., fill in the Unified Social Credit Code, Registration Number, or Organization Code).
- **Communication Address:** Fill in the location address of the enterprise.
- **Enterprise Contact Person's Name:** Fill in the name of the enterprise contact person.
- **Enterprise Contact Person's ID Number:** Fill in the ID number of the enterprise contact person.

- Enterprise Contact Person's Mobile Phone Number: Fill in the mobile phone number of the enterprise contact person.



- Once personal authentication is changed to enterprise authentication, it cannot be reverted to personal authentication.
- From the start of the real-name authentication change to the approval/rejection period, you can revoke the change request at any time, and the real-name authentication information will revert to the original authentication subject.
- From the start of the real-name authentication change to the approval/rejection period, resources and any incurred debts belong to the original authentication subject.






